Minutes:

The annual general body meeting was called to order by the president Dr. Ranganathan, after being collared by Hon.Secretary, the president invited Hon.Secretary Dr. N Chaitanya babu to proceed with the agenda.

Next agenda was to ratify and approve the decisions taken during the EC meetings during the year 2016. All the decisions of EC were ratified by the house. It was proposed by Dr. Anand seconded by Dr. K. Vinod Kumar.

Regarding the journal matters, Dr. BK. Das wanted clarification regarding the process of reviewing the articles and was also critical on the standard of our journal. Dr Radhika MB clarified the queries to the house. Many of the members also complained of non-receipt of journals, regarding this house

suggested to post the journals under the certificate of postings. Hon. Secretary Dr. N Chaitanya babu requested all the members to update their address, as many address were not found by the postal department.

In any other matters, the subject of starting the lab by oral pathologist was brought up. In this regard the Hon. Secretary Dr. N Chaitanya babu told about the limitations of oral pathologist as labs come under purview of MCI regulation and also mentioned about the efforts of including the name of oral pathologist as signing authority in NABL. The topic of job creation was also discussed in the house for budding oral pathologist. Dr. Jay Gopal ray incoming president promised to take up the issue with Dental Council of India.

Regarding collection of Data for oral cancer and pre cancer president Dr. Ranganathan mentioned about difficulties in collecting the Data from various institutions. It was decided to have zonal centres with E.C. Members as representatives to follow up and try to get Data regarding oral cancer and pre cancer across the country.

Since there were no other matters President Dr. Ranganathan adjourned the meeting and Secretary Dr. N. Chaitanya Babu thanked all the members for attending the meeting.
