Subject: Official Advisory on Unauthorized Discussions of IAOMP Bylaws

Dear Esteemed Members of IAOMP,

It has come to the notice of the Executive Committee that a life member of IAOMP is proposing to conduct an "informal meeting" on a public platform—such as YouTube—to discuss the proposed amendments to the IAOMP Bylaws, alongside legal experts and interested individuals. While such initiatives may appear to be consultative or educational, the Executive Committee strongly advises against such activities, as they pose serious risks to the confidentiality, integrity, and unity of the Association.

Please take careful note of the following official guidelines:

1. Authorized Platforms for Discussion

All discussions pertaining to the IAOMP Constitution and proposed amendments shall be conducted exclusively within officially recognized IAOMP forums:

Executive Committee Meetings General Body Meetings

The Extraordinary General Body Meeting (EOGM) scheduled on 14th June 2025

2. Mandated Authority

While every life member is entitled to express queries or concerns, only the officially constituted IAOMP Constitution Committee is authorized to provide clarifications or justifications regarding the proposed amendments. This committee is legally empowered and best equipped with the full context to explain the rationale behind each proposal.

3. Risks of Unauthorized Public Discussions

Informal or unauthorized meetings—especially those held outside IAOMP's sanctioned platforms—without explicit prior approval from the Hon. Secretary or the President:

Risk spreading inaccurate, incomplete, or misleading information.

Undermine the Association's democratic and carefully structured consultative processes.

6. Safeguarding Member Rights and Institutional Integrity

Unauthorized disclosures compromise the confidentiality expected by our members and misrepresent the Association's intentions. They may also infringe on the rights of those who expect internal matters to be discussed within the designated frameworks of the Association.

We urge all members to uphold the decorum, confidentiality, and unity of IAOMP by respecting these guidelines. For any concerns or clarifications regarding the proposed amendments, members are requested to contact the IAOMP Constitution Committee directly or raise them during the upcoming EOGM.
